### FROM THE CHIEF PLANT STEWARD

October 10<sup>th</sup> will be the next time we meet with the company over Step II Grievances. Twenty-eight new cases and two holds will be discussed. The cases we have submitted so far deal with the following: Lean related problems, raises for skilled workers, piecework job rates, O.T. for tool crib workers, farmout, wage issues due to farmouts and management doing bargaining unit work.

Discipline is on the rise again and a lot of it seems to be worker on worker. Once the company gets hold of these disputes, where union members give verbal or written statements, right then the company feels they have just cause and will issue discipline. Most of the time it's a warning and week off, then we end up in a battle with the company through the grievance procedure. The Unity Council is back up and running, and most of the time they resolve problems of this nature. So rather than going to the boss we ask people to go to their steward or contact a member of the Unity Committee directly – Their numbers are listed below.

We're still working on getting the robots into a Lean cell and there has been little activity on Lean in the rest of the locomotive department. The new crash worthiness platform rabbit has gone through the shop and they will be in production by years end. The Egypt and Kazakhstan platforms are moving along and some farmed out span bolster work for the CVRSD was brought back into the shop.

In the propulsion department we're working on a Lean line for the rad fan area, a new burn table in the parts department and adding some positioners in the large motor department. Throughout the building we've seen a lot of new faces added, so I'd like to take this opportunity to welcome all of the workers who recently started in Building 5.

Unfortunately there are always issues on the floor like OT being doled out unevenly, making sure piece prices don't change without reason and making sure seniority is used to fill both temporary and permanent jobs.

## **REPORT FROM BUILDING 6**

First, welcome to our New Hires. We've needed you. We are slowly getting our open jobs filled. Now what we need is a manager that understands production and the importance of relying on Building 6 workers to get the work done.

We continue to **fight farm-outs**. It's no wonder our stock prices are falling considering the profits this company is throwing out the window due to the excessive costs of these farm-outs. An example: in our **grid blower area** where the schedule has increased 25 to 30 percent, we are still unable to get management to put on a  $3^{rd}$  shift. The company is more concerned with their farm-out source than doing the work in-house, at a greatly reduced cost.

The **lack of communication** and unwillingness of the management to work with us is also something we need to improve. In most areas, suggestions offered by the workers, on how to get the work out, are ignored. Though the management uses us as their excuse for not "hitting their numbers", we are not to blame. We always care about putting out good products and having work completed in time to meet the customer's needs, and the workers in Building 6 will continue to meet those commitments in spite of management.

He will also work on several other important projects such as digitizing the grievance records and the pictures the Local has amassed over the years.

### SUB-REGION WORKSHOPS ON UE and NLRB Held at Local 506 Hall

On September 27<sup>th</sup> seventeen Local 506 Members, along with several UE Members from other Locals in our

sub region attended a twopart workshop arranged by Eastern Regional President **Andrew Dinkelaker**.

<u>UE History Workshop</u> - UE General **President John Hovis** conducted the first workshop on "How UE Got started". In this session, John took attendees back to a time over 70 years when the

bedrock of the UE was established, when members of former craft unions joined members of the company unions in Buffalo, NY to charter the UE.

John went on to explain that the UE was uniquely



set up so Locals could have their autonomy, without National control. Further they were set up so no officer could make more than any worker paying dues. Both practices continue to this day.

John then talked about the struggles the UE took on in the early years and

the strikes of 1946 when, after the war and the wage freeze was lifted, UE Members fought for a \$2.00 per day

increase, the restoration of their night shift bonus and the restoration of vacation and holiday pay.

NLRA Workshop – NLRB Field Examiner Terry Yoest opened the second session explaining the history and the operations of the National Labor Relations Act. Terry said the NLRA (also known as the Wagner Act) became law in 1935 to es-

tablish collective bargaining rights for union workers and

to outlaw unfair labor practices. The NLRB Representative then explained Sections 8 of the Act which deals with Unfair Labor Practices of Employers.

**UE Chief Council Polly Halfkenny** followed by the NLRB examiner and talked about the do's

and don'ts of filing NLRB Charges. Polly advised the attendees, "You'll do better and have more rights and leverage if you secure it through your contract" (rather than depending on an NLRA charge). According to the UE attorney, "Typically it takes a couple of years to settle a complaint, if the NLRA violation arises out of an organizing drive, the company uses that time to undermine the campaign."

Polly told the attendees that the labor laws change often as they are based on rulings on court cases and the NLRB's interpretations.

Since they began in September of 2006, Tool Room Steward **John Taccone** (Pictured left) has participated in all of the Eastern Sub Regional workshops. John told the news that he appreciates the opportunity to hear the knowledgeable guests speak on the interesting topics the Sub Region workshops provide.
