## **President's Report**

I would like to start out by thanking the members for their support in making the 2014 Toy Drive a great success. This year we were able to provide a Christmas for many area children that otherwise would not have had a visit from Santa. I would like to give a special thanks to Knights of St. John for their generous donation to our Toy Drive.

The company recently requested to enter into bargaining with us over "continuous operations" under Article V (b) of the National Agreement in some of the lab areas. We responded by informing the company that "that language only applies to jobs such as the powerhouse for reasons of the protection of equipment and materials and process orientated jobs such as chemical, plastic, silicone and glass operations". Because the labs do not fit into either of these categories we are not interested in negotiating "continuous operations" at this time. In the axle machining area of 18T we are still talking with the company about replacing aging equipment in an effort to prevent the TOW of the axle machining area. The company's own numbers show this new equipment would be both a sound investment and a profitable one, however they seem to be reluctant to commit. As of this article there are still 96 people on the street. The company is claiming the recall list should be exhausted by March of 2015 due to the high volume and the amount of retirees.

## National Director Bob Kingsley Speaks to 506 Members

National Director of Organizing, Bob Kingsley attended the November Membership meeting. Brother Kingsley explained the many reasons to organize the GE, Fort Worth Locomotive Assembly Plant. Chief among those reasons is to combat the practice of "whipsawing" union and non-union facilities against one another. Simply put the term whipsaw describes a tactic whereby a company will inform the Union shop that they must match the cost of the non-union facility or the work will be moved to the cheaper shop.

In 6 months Contract Negotiations will begin, the facts are the CBC will be representing 17,000 Union workers at negotiations, that is half the number we represented in 2007. Clearly, some of our contract goals will include improvements in healthcare, wage increases and job security, to mention just a few, but for 4,500 CBC members who won't be GE employees at the end of 2015, due to plant closings and the sale of appliances, their goals will be much different. As Brother Kingsley stated in his report "The source of power during negotiations comes from the membership on the floor".

The lesson is simple, when you enter into contract negotiations numbers matter, the more voices you have the stronger the message, "if we leave these non-union GE facilities unorganized we do so at our own peril".

## L.A.C. Report

#### ! URGENT!! URGENT!

In recent news there have been discussions of legislation that will be brought to vote in regards to Federal Private Pension Laws and the Trans Pacific Partnership Trade Agreement.

So the question is....

"Why does this concern us?"

To start, the pension legislation that has been characterized as a "lame-duck sneak attack on pensions of already- retired workers" is a concern for any worker that *is* or *will* be eligible for a defined pension benefit that has been negotiated or promised to them. Since 1974 cutting solvent pension plans has been against the law. Bipartisan leadership in the House Committee on Education & and the Workforce are working on a bill that would change that. That bill would be a part of omnibus spending package. This would be part of the federal budget and would be voted on with an all-inclusive up or down vote.

Why should this concern us?

In short legislators are trying to address the fiscal distress of the nation's 1400 or so underfunded multiemployer pension plans on the backs of the people on fixed incomes who can afford it the least. Furthermore, this will give companies with fully or over funded pension plans the ability to cut benefits.

The next piece of legislation that should be a concern to us is the Trans Pacific Partnership Trade Agreement (TPP).

This deal is currently being brokered in secrecy by lobbyist and representatives of Multi-National corporations behind closed doors.

During the Bush 2 administration Senate passed the president's request for fast track trade negotiating authority. With that authority President Obama will be able to present legislation for another up or down vote on this trade bill.

From past free trade bills going into effect we have learned that the passage of new trade pacts don't equate to more jobs or higher incomes for American workers. For example NAFTA, "no protections were contained in the core of the agreement to enforce labor or environmental standards." As a result, NAFTA tilted the economic playing field in favor of investors, against workers, and the environment, resulting in a hemispheric "race to the bottom" in wages and environmental quality.

Why should this concern us?

In just 9 years after NAFTA being signed into law

the U.S. trade deficit with Canada and Mexico caused the displacement of production that supported 879,280 U.S. jobs. Most of those jobs were high-wage positions in manufacturing industries. NAFTA has also contributed to rising income inequality, suppressed real wages for production workers, weakened workers' collective bargaining powers and the ability to organize unions, and reduced fringe benefits.

#### That, Brothers and sisters, could directly affect us.

Your leadership has contacted your respected representatives. Now, your concerns and opposition to the passage of these potential pieces of legislation needs to be heard. Please support our efforts by contacting your representatives.

I am pleased to tell the membership that our backlog of Step II Grievances are down to just 33 cases. With the help of your Chief Stewards as well as your Department Stewards, we have been able to resolve many cases before getting to the Step II grievance level. Last month's step II grievance meeting was held on November 21, it went fairly well, we argued a total 35 cases. There were 6 cases that could not be resolved and were sent on to step III. 11 cases were put on hold pending further investigation and will be revisited at the next step II meeting. 18 cases were closed or resolved. Unjust discipline, overtime and pay issues were the bulk of the subjects discussed. The next step II meeting held December 19th. We are in the process of scheduling the next step III meeting sometime in January around the 3<sup>rd</sup> or 4<sup>th</sup> week. There are currently 28 cases at the step III level waiting to be heard. The goal for the grievance procedure is to have good quality grievances heard in a timely manner. A reminder to all Department Stewards when filing grievances fill out a grievance action sheet along with the grievance. The grievance action is to be given to your Chief Steward not the **company**. If you do not have one ask your Chief Steward for copies or come to the hall.
